well my targeting went dormant for a few months there, january up until the very moment i finally stumbled upon what should be the final nail in this conspiracy's coffin. I've been saying publicly and reporting to authorities for 2 years now, Mark, Chris, Jason, Brian, Jeff, and Jordan from the Lackawanna County DA's Office have weaponized National Resources' surveillance technology's 2 way communication ability to psychologically torture me with a singular goal of pushing me to commit suicide. I've been telling everyone this not having any clue that National Resources is actually the CIA's Domestic Division. this is big news and it's forced me to come to the realization that this is not at all in my head, that the surveillance equipment is very real and highly classified. that this is all a very scary real illegal psyop using incredibly effective CIA psyop tactics. this discovery had the operation demand once again i enter rehab. scared as hell it's actually the CIA behind it all but still not addicted to drugs since the first i lied my way into rehab. thinking that finally this hellish nightmare would be over i was relieved. being targeted with voices again and entering rehab has absolutely and completely destroyed my relationship with both of my parents. my father went as far as to kick me out of his house and I'm no longer even allowed at my mother's house to visit. i have a saint of a mother and i have always proudly been a momma's boy, so this is devastating and penny less I'm also now homeless. and guess what, the psyop continues anyways.

knowing the final detail about the CIA I've sent them 4 letters in writing and filled out their online form hoping to settle this discreetly. in response they have decided to double down on their attempts to openly push me to suicide. it is now the only topic directed at me, promising me like it's a fact "you are going to kill yourself." obviously I've made my position clear since the beginning, that no one should ever be subjected to these extreme levels of psychological abuse and trauma. there is just zero defenses or ways to combat against this type of attack. I'm suffering extreme levels of psychological trauma and having a hard time persevering.

this is forcing me to do the impossible, something i haven't even been able to get a lawyer to even advise me on, to go against the CIA. I'm clearly forced to only describe the psyop and what I'm experiencing by using descriptions of current technology and bring to point the fact that it isn't my job to explain clearly classified advanced surveillance technology. this is still very daunting but i feel like it might be possible. I'm going to use my head and become the problem i need to be to finally end this.

clearly the state police have been complicit in this conspiracy but hopefully bringing this new CIA revelation and the fact that it's still not only continuing 2 years later but is worsening. I'm going to remind them of their integrity and service for Pennsylvanian's. that they really can't continue to turn a blind eye to this.

they are likely going to still dismiss me. so I'm going to have to find help from someone from your office, so i appeal to your empathy. I've heard psyop operators from your office vocally walk away from the program saying "I'm not going to be a part of this kid committing suicide." and the hero female operator who disclosed the National Resources fact. in my mind the fact that I've been saying National Resources for 2 years and now revealing that that is actually the CIA behind it all is absolutely hard evidence. if i have to I've been brainstorming ways to get my story and evidence into the media. I've made it clear I'd rather be on the side of the CIA and would easily get on board to end this, but instead I'm being forced to go against you and the CIA. they haven't killed me, so i wouldn't worry about anyone killing you, and if i could just get someone on board to threaten to be a whistleblower this hell could finally be over. we would obviously be taken seriously and settle quietly no where near actually going to court. it's been

clear from the start this joint investigation was started on false intel and i am very much an innocent Pennsylvanian with no criminal or arrest history. even if i was told, i would still never be able to understand why I'm being targeted like this. even if i was the worst criminal, no one should ever be subjected to such abuse. when i think about these words, when i feel them with my whole existence, they feel true, No One Would Ever Do This To Me. and that's why they've been able to get away with it for so long.

I've condensed most of my knowledge of this investigation into a single page but i forgot to mention the fact that in the beginning, during the first month, i was openly stalked and terrorized so hard that i called the state police 3 different days on drug task force members. that tormenting me from the woods outside my place they got the state police called on themselves for firing guns off. i could write a book describing everything and the encounters where i learned names and details about this psyop.

now's your only chance to get together with me and we can settle this matter and finally move past it. I've have no other option than to pursue criminal and civil charges against you, the Lackawanna County District Attorney's Office, and also the CIA National Resources Division. i am going to be a problem, i am going to tell the world about this. my goal is going to be to get a committee to investigate the CIA for targeting innocent American citizens, i am far from the only one being targeted. I'm going to make everyone's lives a nightmare, but not like mine, i would never ever let anyone ever get targeted for being pushed into committing suicide. just the thought of it is still something i would ever let slide. you are all complicit in this evil conspiracy and I'm going to work my hardest that everyone is held accountable for it. this is your problem that you've made for yourself.

My name is Matthew Roberts I am from Carbondale PA, I have no criminal or arrest history but because of false intel from a criminal informant I have been put under a joint taskforce narcotics investigation. The city of Scranton PA's Lackawanna County District Attorney's Office in concert with National Resources (C.I.A.'s Domestic Division) put me under investigation the summer of 2020. Their C.I.'s Dan Bell and Tonya Perry told the DA's office exactly what they wanted to hear to get themselves out of trouble. They were looking for controlled buys off of out of state drugs dealers. I had recently moved back home to PA from NM and did have out of state plates, but I was a local and certainly never been a drug dealer or criminal of any sorts. These men got excited to have a target for their joint taskforce and did not vet this intel. Any look at all would have shown what was obvious, I was homeless and the car in question was a \$100 car I got from the junk yard. Dan confessed to me he did this and thought I wouldn't get in trouble because you need two controlled buys for an arrest. For two years I knew I was under investigation by the Lackawanna Drug Taskforce and I would occasionally hear shift changes and status reports on my behavior. It was mostly a woman I would hear. I figured they were using their surveillance bugs as a two way communication device to make me paranoid and harass me. I was suffering thru a severe depression and active addiction, the worst downward spiral of my life, and the Lackawanna County DA's office watched me suffer thru it. Apparently the next step of the investigation was to get me into a drug and alcohol rehab, I assume to retrieve their surveillance equipment because a few weeks after I had quit fentanyl at home without going to rehab and with no charges to bring against me, they decided to expose themselves and their surveillance equipment. May 2022 they weaponized their surveillance equipments two way communication ability and started a 20 month long C.I.A. sponsored torture psyop. For 2 years everything was above board and I had no clue how completely compromised I was by their surveillance technology. Knowing I was under investigation did not make me paranoid, I do not fear the police, I have nothing to hide. I figured the worst that would come from the investigation would be my first possession charge. I was waiting for them to finally talk to me, tell me to goto rehab or I'm going to end up in trouble. They did not have to expose themselves and I believe they started the psyop inadvertently. At first they were tormenting me threatening to kill my mother, my dogs, my entire family, by name, on repeat to get me into a rehab. They obviously sprung this psyop on the cops and detectives at the DA's office because they made a lot of mistakes, I even heard one operator be vocally opposed saying "I'm not going to be a part of this kid committing suicide." Thru human error and a single act of empathy I learned 6 names of the people involved from the DA's office and who is behind the surveillance technology/psyop. Leads of the program are district attorney Marc Powell and Chris. Chris might be lead detective Chris Kolcharno or possibly the chief of the drug task force is named Chris. Some of the detectives are Jason, Brian, Jeff, and retired detective Jordan. I recognized Jordan's voice on my own, I've known him my entire life. The lady voice I'd hear from the surveillance bugs confirmed about the faked controlled buy, she exposed Marc's name, and she is the one who told me National Resources. I also received a phonecall claiming to be from the PA Attorney General's Office telling me the Lackawanna County DA's office is behind the attack. They have been operating this illegal psyop torture conspiracy with singular goals of me taking my own life for over two years. When I beg for them to just finally kill me their only cold response is "You're Going To Do It Yourself." No one should suffer like this. It took me 2 years to discover that National Resources is the C.I.A. and now that I know this problem needs to be handled. They are not stopping on their own.
