hey i reached out 17 months ago about this, i am an innocent victim, my name is matthew roberts 179681107. these men obviously planned to torture and murder a drug dealer, and were misinformed that i was one. they didn't look into me and they jumped the gun. i am no criminal. I'm not always proud of where im at, but i am proud of who i am. i even worked for the D.o.D a couple years. they decided to continue their torture dreams on me anyways. they been in my head over 3 years, and torturing me 24/7 for 18 months. I've come to know these men by name. marc powell, the DA, and chris kolcharno, lead detective. and drug cops jason, brian, and jeff. its gotten so far out of hand I've been posting youtube videos and live tweeting the torture, both under the handle @elphhh . i sure as shit do not want to be a risk to national security, but i just don't know what else to fucking do. its been 18 months and they will not stop themselves. i keep telling them, for months, I'm going to continue to be proactive with the knowledge they've cursed me with until someone stops them, if they just won't stop themselves. i told them I'd delete everything and forget about this madness if they paid me, i don't know what else to take in return for 3+yrs of suffering, 18 months of torture. if i got paid I'd gladly take down the videos and post it was a hoax and further discredit other targeted individuals. if these men aren't going to prison, I'll need to be paid, or murdered. it's not something I'm willing to let go without restitution. I've been worried about my life more than ever lately, so all my evidence is locked in my parents safe. ive gone so far out as to reach out to newspapers and tv stations to look into this torture. i warn them weeks in advance before I'm proactive about outing them. i understand the importance of this work and technology, but this is gross neglect.

please straighten this mess out before they get themselves and/or you in trouble. they are obviously not going to do it on their own.

I've been leaving messages with the fbi Scranton field office for a couple days. please help or call someone who can help.

I've never been a criminal and I've never been a bad person. i don't even litter.

please look into what is going on in your office. if you're in the dark, my life is at stake.. thank you for calling the Carbondale police last email, all they did was a well fare check.

please look into the actions of the people in your office. it's been over 6 months and I'm still constantly harassed 24/7.

my name is matthew roberts, i live in carbondale 179681108

I'm not a criminal and I've never been one. people i believe from your office are harassing me, they are insisting i either go-to rehab, or kill myself. I've been sober for a couple months and I'm still being harassed.

I've picked up these names from them bickering between each other while harassing me.

marc, chris, justin, jason, brian, jeff..

please look into what your staff has been upto.

no one deserves to be treated like this.

To whom it may concern:

My name is Jo-Ann Bevacqua. My son Matthew Roberts asked that I put pen to paper to explain how his current situation has affected me personally.

My son's father Francis Roberts, called me on May 20th, 2022, to let me know that our son Matthew confided in him that he was being harassed and threatened. He believes the harassers are members of the Lackawanna County Drug Task Force.

He stated that he believes he's been under investigation for selling drugs. He had told me previously that he was almost arrested by the Task Force several months ago when trying to purchase drugs. The Task Force showed up at the Dollar General in Carbondale and arrested the seller. No drugs were found on Matthew therefore no charges were ever filed.

He said they talk to him and only him and has stated numerous times that they've threatened him with bodily harm if he doesn't go to rehab. They've threatened to kill his dogs as well as me. The threats are causing him severe anguish and he wants them to stop. This has affected his physical and mental health tremendously as he's living in a constant state of fear. This has been happening continuously and he's deteriorated over the past 4 weeks.

On Friday, June 3rd Matthew asked me to take him to Wilkes-Barre to see a lawyer that handles civil matters. I assumed he had an appointment but that was not the case. He was hoping to speak directly to Attorney Barry Dyller. When we arrived there was a note on the door that stated Walk-In's are not permitted and it provided a phone number. Matthew called and got through to Attorney Dyller and tried his hardest to get a face-to-face meeting. Dyller declined. Matthew provided some details and the lawyer said he was crazy and hung up. I tried explaining to him that without proof he won't be able to get anyone to take his case.

Matthew asked that I purchase an Anti-Spy (Radio Frequency) Detector on June 4, 2022. I did. It arrived on Monday, June 6th. He said it lit up like a Christmas tree and had called his father to come and see. I spoke briefly with his father and told him that the instructions say to turn off cell phones. Once they put their phones on airplane mode the RF reader was quiet unless the frequency was turned all the way up.

I checked in with Matthew the next morning. He texted that if I was worried about him to come and get him. I did. He played a few recordings from his phone in the hopes that I could hear the threats, but I could only hear him. We then went down to his father's sheet metal shop in town as he said he had recordings on the computer there. I still couldn't hear the threats. That's when I told him I believed he was in psychosis. I was ready to 302 him that day but he agreed to 201 himself on June 8th to Geisinger CMC.

He was transferred the next morning to Pyramid Hillside in East Stroudsburg on June 9th. He completed detox and signed himself out on Tuesday, June 14th.

As to the morning of Wednesday, June 15th I woke up to a text he sent at 11:32pm the previous night. He asked that I write to the Lackawanna DA's office about what me and his father have been going through. He's asked me to include the name of the people involved. (The names he's provided are Brian (Carbondale Police Chief), Jason, Chris, and CJ.) I message Matthew back at 4:59am in the morning and

he asked that I call him. He told me he had a tough night but that he was doing okay. He then texted me a picture of District Attorney Mark Powel stating he's the person behind all the harassment.

I got in my car and drove to Salem Mountain and blew the horn. I then looked down at our text messages and saw that he had written that maybe it was better that his father come instead of me. I was afraid to knock on his door as he's been threatened that they would kill me if he didn't go to rehab. I then called his father, Fran. Fran said they he had just gotten off the phone with Matt and that he'd be right there. As I waited outside, I could hear Matthew talking. Both his father and I heard the panic in his voice and were extremely scared for our son. Fran knocked on the door as it was locked. Matthew asked who it was, and his father had to answer twice. When Matthew opened the door, he told us that he cannot take the torture anymore. The threats to him, his dogs and his family are unbearable. He asked us to go report all that's been happening to him. I told him we were helpless to take any action without direct proof. It tears us both apart to see our son in such pain and anguish. I believed at that moment my son was going to have a nervous breakdown. I started to mention an article I read, and he shut me down. He acted like I betrayed him somehow. That's not true at all - I would never betray my son. I'm just searching for a reason as to why this is all happening to my son. He went back into the building and closed the door.

After that his father spoke to him briefly but was unable to calm Matthew down. I didn't know what else to do and felt that my son needed immediate attention. I told his father I was going to 302 him and drove the Geisinger CMC. I filled out the paperwork stating that he's been seriously thinking of suicide and laid down on the road in the hopes that they would run him over.

The PA State Police received the warrant for Matthew and brought him to Geisinger CMC. He was released from the hospital later that afternoon. His urine test came back negative for drugs, and he told the hospital staff that the voices he was hearing stopped while he was in detox (from 6/8 to 6/14). He also told them that the suicide threat I cited wasn't current.

This ongoing torment of my son has caused myself and my ex-husband much anxiety. He's on our minds constantly. I've lost my appetite and have lost weight. I don't sleep well as I wake up wondering how Matthew is doing. I'm more forgetful and have a hard time concentrating. It's like I've developed ADHD. I'm sure his father is in a similar state of mind.

We need this to end. We need our son back.

My name is Matthew Roberts. I'm from Carbondale PA. In 2020 the Lackawanna County District Attorney's office was misled to believe I was a drug dealer. A C.O. by the name of Dan Bell made a fake controlled buy off of me. The D.A.'s office then decided to use alien technology to invade my mind. I have no criminal history, I'm 39 yrs old & never been on probation. They did not even do a background check on me. The name of the technology or whoever gave it to them is National Resources. Marc Powell & Chris are the leads of this program. In May of 2022 they switched from surveillance to a 24/7 torture program. Stalking me in person, pointing directed energy weapons at me. I would smell burning hair & have burning sensations on my body. At one point Marc, as a show of force, stopped my breathing. He said "open your mouth & embrace death," and I couldn't open my eyes or breath for ~~over~~ over a full minute. They harass & torture me in my own mind 24 hours a day. Openly trying to convince me to commit suicide. They constantly threaten to kill my dogs, my mother, my entire family by name, on repeat. Over and over. I attempted suicide once, & all that happened is they laughed at me. I have come to know some of these men by name. Drug cops Jason Brian & Jeff. I have heard the voice of a retired detective I've known my whole life, detective Jordan. The last thing he said was "do not trust the police, they are going to kill you." Everything I know has been told to me in my own mind.

In the beging I only ever heard a woman's voice. She is the one who said National Resources. Find her & I think she would confess. her as ~~Det~~ Detective Jordan. No one should ever have to suffer like this. If I am dead please put these men in prison. I have shared all of this information on twitter & youtube. under the handle @delphhh. I write this incase they delete that. I am afraid for my life & the life of my family. I have reached out for help to the local & state police, FBI, & PA attorney general's office. When I reach out to the attorney general's office I get new voices in my head torturing me. They are directly involved.
