I'm contacting every email i could find for inspector generals in a last ditch effort to try and reach the inspector general for the CIA. the only contact information for them is postal mail. i have sent them this information today but I'm not certain they'll receive it in time.

please relay this information up the line or directly to them whatever it takes to try and end this. i want to be on their side.

the Lackawanna County District Attorneys Office in Pennsylvania has exposed the mind control technology given to them by the CIA's domestic division National Resources. they have been using it to telepathically torture me for 2 years. I've reached out to all of the local, state, and federal agencies that i could think of to try and get them to stop. my last ditch effort is trying to reach the CIA's inspector general.
